### ● TOWN ORGANIZATIONS POLICY UNDER CONSTRUCTION ●

The Town Council is developing a policy framework for Town organizations that will establish criteria for "Recognized Organizations" as opposed to loosely organized "Groups." Privileges, such as use of Town facilities, listing in Town print and online publications, and eligibility to request budgeted Town funds, would be dependent on fulfilling certain requirements. Requirements currently under consideration include: annual application for recognized status; liability insurance; checking account, formal budget requests and annual financial reports. 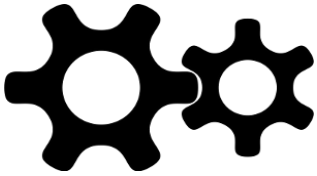

## **RECYCLING BIN SURVEY RESULTS**

Eighty-eight residents responded to the Survey published in the October 2017 Bulletin. The following responses were received:

## **RECYCLING - DID YOU KNOW?**

Most types of plastic, glass and metal household containers are recyclable, as well as newspapers, most types of office paper and cardboard boxes, if flattened. Help the Town improve recycling outcomes by NOT recycling the following:

• NO Plastic bags or plastic wraps	• NO Food, or any container with food residue
• NO Styrofoam and bubble wrap	• NO Used tissues and paper towels
• NO Chip bags	• NO Aerosol cans
• NO Plastic utensils	• NO Clothes hangers or anything that can get snagged in sorting machines at recycling facilities



## **LEAF COLLECTION ENDS DECEMBER 28**

Curbside leaf collection ends Thursday, December 28th. Residents who prefer to bag their leaves for pickup may do so using brown paper lawn bags only. Bagged leaves will be picked on yard waste collection days.

- Please rake your leaves to the curb or to an existing sidewalk, but NOT into the street.
- Do not mix loose leaves with sticks, rocks, trash or debris, as they can damage the leaf machine.
- Do not mix loose leaves with tree trunks or thick branches. They are collected separately.
- Do not park cars in front of leaf piles, as this hampers access by the leaf vacuum machine.
- Be advised that it takes approximately 2 weeks to complete a round of leaf collection in Town.

## **Friendly Reminder: Refuse and Recycling Collection Rules**

- ✓ Public Works only collects refuse (trash) if it is set out in a container with a tight-fitting lid. Public Works DOES NOT collect refuse if it is set out in a bag alone at the curb.
- ✓ Refuse and recycling must be ready for collection by 6:00 a.m.
- ✓ Any materials such as broken glass, nails, or other sharp objects must be placed in a durable container before being placed in the collection container to protect the employee's health and safety.
- ✓ Bamboo is considered refuse, not yard waste, and must be cut in 4-foot lengths then tied in bundles and placed next to the refuse container.
- ✓ Town residents can dispose of electronic items through the City of Greenbelt's quarterly drop-off event.
- ✓ Leaves are collected from the curb in November and December. During all other months, leaves and other yard waste must be bagged for collection in appropriate containers such as paper yard waste bags available for purchase at local hardware stores, or tied in bundles.
- ✓ Public Works will collect the following items only after making a request to the Town Office and paying the applicable fee:
  - Appliances
  - Bulk waste, such as furniture and rugs
  - Items left behind from the previous tenant or occupant
  - Motor vehicle parts and accessories up to 50 pounds and free of any hazardous materials
  - Tires
- ✓ Public Works DOES NOT collect building, construction, flooring or remodeling materials, or any hazardous materials.

- ✓ Obras Públicas sólo recolecta basura si se encuentra en un contenedor con una tapa ajustada. Obras Públicas NO recoge la basura si se encuentra en una bolsa sola en la acera.
- ✓ Los desperdicios y el reciclaje deben estar listos para su recolección antes de las 6:00 am.
- ✓ Cualquier material como vidrio roto, clavos u otros objetos afilados deben colocarse en un contenedor duradero antes de ser colocados en el recipiente de recolección para proteger la salud y la seguridad del empleado.
- ✓ El bambú se considera basura, no el desperdicio de yarda, y se debe cortar en longitudes de 4 pies después atado en paquetes y colocada al lado del contenedor de basura.
- ✓ Los residentes de la ciudad pueden disponer de artículos electrónicos a través del evento trimestral de la Ciudad de Greenbelt (City of Greenbelt).
- ✓ Las hojas se recogen de la acera en Noviembre y Diciembre. Durante los otros meses, las hojas y otros desechos del jardín para su recolección deben estar en recipientes apropiados, tales como bolsas de papel, disponibles en tiendas de ferretería locales o amarrados en paquetes.
- ✓ Obras Públicas recogerá los siguientes artículos solamente después de hacer una solicitud a la Oficina de la Ciudad y pagar la tarifa aplicable:
  - Electrodomésticos o Accesorios
  - Residuos a granel, como muebles y alfombras
  - Elementos dejados por el inquilino o ocupante anterior
  - Partes y accesorios de vehículos de motor de hasta 50 libras y libras de cualquier material peligroso
  - Llantas

## Worksession

October 2, 2017

### Executive Session (6:00 – 7:05 p.m.) Personnel Matter

#### Regular Meeting

The meeting was called to order at 7:07 p.m. Present were Mayor Cheryl Jewitt, Mayor Pro-Tem (MPT) Jodie Kulpa-Eddy, Councilmembers (CMs), Patricia Dennison, Christopher Rasmussen, and Gerald Shields. Also present were Town Administrator (TA) Jessica Cowles, Chief Kenneth Antolik, Clerk Kerstin Harper and citizens. Several citizens had signs expressing opposition to the acquisition of the Humvee.

#### 1. Action Items

**Humvee acquisition:** Chief Antolik presented additional information on the Humvee the Council had requested: Out of 7 neighboring municipalities, all have utility vehicles and 4 have Humvees. The University of Maryland has 8 SUVs, 2 Humvees and 1 peacekeeper. The Humvee the Town applied to acquire has 4 seats and each one is equipped with a seat belt. The installation of a hitch would cost approximately \$100 plus \$200 for installation. Humvees are made to withstand water inside the vehicle and are equipped with drain holes in the floor. In certain types of weather this can lead to condensation on the inside of the windows.

In response to questions, Chief Antolik replied that he has seen no evidence of mold in the vehicle. The Humvee has 4 seats but 2 are currently not visible because they are folded down. The removal of the turret would be difficult and expensive because it would require removal of the roof. In addition, the turret would have to be re-installed if the vehicle is returned or transferred to another agency. Other municipalities use Humvees for search and rescue and driving in severe weather. The Humvee was acquired under the Defense Logistics Agency's 1033 program, which restricts its use to law enforcement personnel. This would exclude any Public Works staff or NW/EP members from driving the vehicle, with or without the Emergency Preparedness trailer. Fire Departments may apply for military surplus vehicles under a different program.

Mayor Jewitt said that she received many calls and e-mails this weekend about the Humvee acquisition and thanked everyone for their engagement. She summarized some the recent comments she received. Two residents sug-

gested to turn the vehicle over to the BHVFD, with the Police retaining ownership, but this option is ruled out by the terms of the 1033 program. Over the last 2 months, she received a total of 34 comments in favor of the Humvee acquisition and 12 in opposition.

CM Dennison moved to approve the acquisition of the Humvee. The motion failed for lack of a second. TA Cowles was instructed to begin the return process.

#### 2. Discussion Items

##### **EOP and Emergency Preparedness**

**Workshop debrief:** TA Cowles explained that the emergency management workshop recently held in Berwyn Heights addressed several important issues pertaining to the Emergency Operations Plan (EOP) the Council is in the process of revising. The issues in question relate to the role of Councilmembers in an emergency situation, particularly with respect to:

- Communication;
- Assessment of community needs;
- Making policy decisions;
- Supporting response efforts; and
- Role in the incident command structure.

The workshop facilitators recommended that councilmembers' role in emergency management focus on making policy decisions, setting strategic objectives, and providing leadership to the community. They ought not have a formal role in the incident command structure, nor take on operational responsibilities handled by Town staff.

In response to Councilmembers questions, TA Cowles said that Berwyn Heights may not have enough staff to handle all emergency functions. The facilitators' recommendation of having 3 staff cross-trained for emergencies in each department is not feasible. However, it is current policy that all essential employees be available during an emergency. The extent of the Council's involvement in operational issues requires more input from the Council, as does the definition of a spokesperson versus those of a public information officer (PIO). Normally, a mayor acts as the Town's spokesperson, whereas a PIO handles the behind-the-scenes work of writing press releases, posting news to social media and websites, and responding to press inquiries. TA Cowles or Clerk Harper may be plausible candidates for this role.

TA Cowles said it was further recommended that the responsibilities of the Community Emergency Response Team (CERT) be clarified. On the latter point, the EOPs of the City of Laurel and the Town of University Park have pertinent information. Lastly, the workshop provided an excellent networking opportunity with emergency personnel from neighboring cities and local agencies that are critical during a crisis. TA Cowles plans to revise the EOP based on the workshop deliberations, but requested Councilmembers to provide additional input on what their roles should be.

Councilmembers proposed the following changes to the EOP:

- Assign emergency planning functions to the Council and operational functions to staff;
- Ensure that emergency policies conform with the Town Charter;
- Clarify whether a quorum of the Council is required to make decisions during emergencies;
- Clarify how to ensure continuity of government;
- Add provision on PIO (see Greenbelt's PIO);
- Add a concept of operations (see Laurel's EOP) to set forth parameters for Town's emergency response.

Mike Attick, 63rd Avenue, asked a question about the purpose of referencing an emergency ordinance. TA Cowles replied that the Town Charter sets forth a process for adopting an emergency ordinance that suspends some notice requirements to enable a faster adoption process.

**Public Works strategic plan items:** TA Cowles gave a status report on Public Works strategic plan action items comprising:

- Conducting a street condition assessment and street improvement plan;
- Researching options for improving facility security over the short term;
- Conducting a Town facilities study, specifically to identify long-term space for the Police Department.

TA Cowles said that, following the departure of Director Cox, there is no one in the Public Works Department who can complete the strategic plan action items. She anticipates that a new director will be hired by the end of this year who

would resume this task. In the interim, she is willing to serve as “acting” director, while hiring Kenneth Hall, who served as interim Public Works Director last year, as a part-time consultant. He would help the Town move forward with the strategic plan and complete a number of pending projects. The 10-week consultancy can be financed within a \$20,000 FY 2018 appropriation for developing a street improvement plan. As an infrastructure expert, Mr. Hall will be able to conduct the street condition assessment and develop a priority street improvement plan with a cost estimate for next year’s budget.

In response to questions, TA Cowles said that Mr. Hall prefers to come in as a consultant rather than a temporary employee, which avoids additional benefit costs for the Town. The job announcement for the Public Works Director has been posted at Indeed.com, in the online “Employment Opportunities” at MML, and will be posted on the Town website shortly. CM Rasmussen moved to approve the expenditure of up to \$20,000 to hire Mr. Hall as a temporary consultant. CM Dennison seconded. The motion passed 5 to 0.

### 3. Minutes

The Council reviewed the September 11 worksession minutes. On a motion by CM Dennison and second by CM Shields, the minutes were approved 5 to 0. The September 13 Town meeting minutes were distributed.

### 4. Announcements, Department Reports, Citizen Comments

Mayor Jewitt reported that some residents received the College Park elections guide because of the zip code issue; that the Ice Cream Social ended early because the fire department checked on a potential gas leak; that Pepco was sent a list of addresses of customers to check into a recent fair-weather power outage; and that the newly-installed crosswalks look great. College Park will celebrate College Park Day at the Aviation Museum on October 7 and the University of Maryland has a Golden ID program allowing senior citizens to take courses. Mayor Jewitt thanked Chief Antolik for his professionalism regarding the Humvee acquisition and all residents who provided input. She explained that she initially was very much in favor of getting this almost free vehicle. She authorized the Town Administrator to apply for it without bringing the matter before

the Council because the decision had to be made quickly in order to qualify. Upon being provided further information about the vehicle, it was learned that the Humvee had a turret for mounting a machine gun that could not be removed without damaging the roof. This made it more difficult to make the Humvee look like a civilian vehicle and allay concerns about the “militarization of Berwyn Heights police.” In addition, the Council agreed to look into obtaining a vehicle, other than a Humvee, with similar functionality. These considerations caused her to refrain from voting in favor of obtaining the Humvee earlier this evening.

CM Rasmussen reported that he, Mayor Jewitt and Treasurer Rodriguez all graduated from the Academy for Excellence in Local Governance. The ceremony took place at the UMD chapel on September 26. He will meet this week with TA Cowles and Code Supervisor Glass to discuss coordination between the Code and Public Works Departments regarding refuse disposal education and enforcement of regulations. Also on the agenda are implementation of new regulations in the amended Clean Lot Ordinance, and setting parameters for revoking a rental license. CM Rasmussen, in commenting on the Humvee acquisition, said that Mayor Jewitt made the best possible decision under the circumstances, that it is unfortunate an arrangement for the Volunteer Fire Department to use the Humvee could not be worked out, and that the needs of the Town’s vehicle fleet should be further discussed.

CM Rasmussen also received a citizen comment regarding the cost of disposing large amounts of bamboo and possible assistance from the Town. TA Cowles will follow up, and look into the best ways to assist residents with removing bamboo.

CM Shields reported on recent and upcoming Town events, encouraged residents to participate in the recycling bin survey, and thanked Chief Antolik for supplying the Council with all requested information to make an informed decision on the Humvee acquisition.

### 5. Town Council Schedule

The Council reviewed the calendar. No changes were made.

The meeting was adjourned at 8:50 p.m.

## Town Meeting October 11, 2017

The meeting was called to order at 7:00 p.m. Present were Mayor Cheryl Jewitt, Mayor Pro Tem (MPT) Jodie Kulpa-Eddy, Councilmembers (CMs) Patricia Dennison, Chris Rasmussen, and Gerald Shields. Also present were Town Administrator (TA) Jessica Cowles, Chief of Police Kenneth Antolik, Code Compliance Supervisor Freddie Glass, Treasurer Michelle Rodriguez, Clerk Kerstin Harper, Green Team and Recreation Council Member Diana Agonoy, Berwyn Heights Historical Committee (BHHC) Chair Debby Steele-Snyder and citizens.

Mayor Jewitt led the Pledge of Allegiance.

### 1. Minutes

Clerk Harper read a summary of the September 13 Town meeting minutes. On a motion by CM Dennison and second by CM Shields, the minutes were approved 5 to 0.

### 2. Mayor’s Report

Mayor Jewitt noted that the Council held an executive session at the October 2 worksession regarding a personnel matter. During that same worksession the Council declined to approve the acquisition of a Humvee and decided to return it to the Defense Logistics Agency. The Mayor and Council received numerous comments on the matter, both for and against, which were appreciated. Mayor Jewitt said she ended up not endorsing the acquisition because the Humvee has a turret for the use of a machine gun, which conflicted with the civilian purpose of the vehicle. The turret would have been difficult and expensive to remove. She is now looking forward to a Council discussion on obtaining another type of emergency vehicle.

Mayor Jewitt said the September 26 emergency management workshop, hosted by the Town of Berwyn Heights and organized by TA Cowles, was a great success. This opinion was shared by representatives from 25 different Prince George’s County municipalities, agencies and community organizations who were in attendance. She recently graduated from the Academy of Excellence in Local Government, which offers training for municipal officials during MML conferences and, starting tonight, will attend the MML fall conference in Rockville.

### 3. Department Reports

Administration: MPT Kulpa-Eddy announced a number of upcoming meetings. On October 12, a Parkdale High School College & Career Fair will be hosted by County Councilmember Danni-



elle Glaros. On October 16, 17 and 23, Prince George's County will hold "snow summits", where anyone can obtain information on the County's snow clearing operations. On October 16 and 18, WSSC will hold a second round of hearings on new a rate structure for water usage that the agency has been ordered to develop because the current rates have been ruled unfair to high volume users.

Starting on October 14, a number of meetings on the environmental impact of a proposed SMAGLEV train are scheduled to take place. Governor Hogan has expressed concern about any routes that would go through densely populated residential areas, which Berwyn Heights shares. Prince George's County will hold a series of listening sessions on the Zoning Rewrite Comprehensive Review Draft starting on October 25 and comments due by December 15. The Town Council is likely to take this up at an upcoming worksessions. A Four Cities meeting is scheduled for October 25 in Greenbelt. Lastly, MPT Kulpa-Eddy invited feedback on the Town's revised Emergency Operations Plan (EOP), which is available on the Town's website and in the Town office.

**Treasurer's Report:** Treasurer Rodriguez gave the Treasurer's report for September, and announced that Town employees recently completed defensive driving and CPR/ First Aid training. A flu clinic for employees and any residents who wish to obtain a flu shot will be held on November 8.

**Town Administrator's Report:** TA Cowles congratulated Treasurer Rodriguez on obtaining her Academy for Excellence in Local Governance certification. She then reported that the main event in September was a very productive 6-hour emergency management workshop facilitated by Texas A&M staff, and attended by 48 high-level representatives from 25 different Prince George's municipalities and government agencies. The afternoon portion featured two table-top exercises on responding to a major snow storm and a health emergency. A number of things learned from the workshop were incorporated into the new EOP, which will be reviewed at the upcoming worksession and is up for adoption at the November Town meeting.

TA Cowles said another important accomplishment was the submission of the Sustainable Communities Designation application. The final product was the result of good cooperation between Ad-

ministration staff and a workgroup representing the Town Council, the Town's commercial district and several civic organizations. The Department is also working on the final phase of the FY 2017 audit, employee performance evaluations and the recruitment of a new Public Works director.

In response to a question, TA Cowles said that she expects to receive an initial response on the Sustainable Communities application by the end of October.

**Code Compliance:** Code Supervisor Glass gave the Code activities report for September. A total of 46 code violations, 5 building permits and 5 dumpster permits were issued. Seven new rental properties were licensed and two reverted to single family homes, for a total of 212 rental properties. The Department's count of vacant homes was 9.

CM Rasmussen reported that he met with TA Cowles and Code Supervisor Glass to discuss several important Code issues, including: 1) how the Clean Lot Ordinance is working 1 1/2 years after being revised, particularly the enforcement of violations regarding accessory structures, invasive species and abandoned vehicles; 2) the circumstances under which the Town might revoke a rental license; and 3) improving coordination between the Code and Public Works Departments in enforcing refuse disposal violations.

CM Rasmussen elaborated on conclusions that arose from the meeting. The Town's efforts to improve residents' recycling and refuse disposal habits should focus on 3 areas: 1) education; 2) enforcement; and 3) equipment (the 3 "E's"). Administration and Public Works would primarily handle the educational efforts by publicizing information about the Town's refuse disposal rules and leaving notices at properties with refuse violations, while Code would be responsible for enforcement. He also suggested the Council consider updating and combining *Ordinance 117 – Refuse Collection* with *Ordinance 107 – Clean Lot* to create a single property maintenance ordinance.

CM Rasmussen further noted that TA Cowles and the Code Department are working with a group of property owners on Ruatan Street, who have joined forces in eradicating a large stand of bamboo. To assist with the disposal of bamboo, the waiving of the Town's dumpster permit fee is being considered. Lastly, he thanked Mayor Jewitt and Chief Antolik for bringing attention to the need for an

emergency utility vehicle, which the Humvee was intended to meet. He is looking forward to a broader discussion about the mission of the Police Department and the vehicle fleet needed to accomplish that mission.

**Parks and Recreation, Education and Civic Affairs:** CM Shields reported that he attended an extreme emergency drill at a recent CERT conference. He reminded residents of an October 13 Paint 'n Sip fundraiser, a November 8 flu vaccination clinic, and filling out and returning a recycling bin survey published in the last Bulletin by October 27. He also encouraged residents to provide feedback on the proposed MAGLEV train routes, either online or at an upcoming meeting. He expressed the opinion that only the straightest routes should be considered for this type of high-speed train. Lastly, he announced that the Maryland Defense Force will celebrate its 100th anniversary with a parade at the Baltimore Armory on October 21, in which he will participate. Anyone interested may come out to watch.

**Public Health and Safety:** Chief Antolik gave the police activities report for September. There were 6 Part I offenses in September versus the 5-year average of 7.8. The year to date total is 44 as opposed to the 5-year average of 48.8. The Police also issued 195 municipal and state citations and 18 speed camera tickets.

Chief Antolik advised residents not to drink and drive following the Paint & Sip fundraiser. Officers will be out patrolling. Over the last month, BHPD officers have been monitoring certain streets for speeding and running of stop signs. The average recorded speed was 26-27 mph, for which tickets are generally not issued. However, vehicles running stop signs will be cited. He concluded with providing Halloween safety tips.

In response to a question, Chief Antolik said that Berwyn Heights Police offer free home security reviews. Interested residents should call the Police Department at 301-474-6554. CM Rasmussen commented at length on the police report, including the number of speeding tickets and stop sign violations issued, the amount of commuting miles driven in police vehicles, and the challenges of dealing with Halloween trick or treaters.

Mayor Jewitt congratulated Chief Antolik on his 27th anniversary of serving in the Berwyn Heights Police Department. She advised that common sense safety rules also apply at the upcoming Halloween

Trunk or Treat event, especially around the fire pit.

**Public Works:** TA Cowles reported that the Public Works crew continues to install crosswalks around Town, and has corrected roadway speed limit markings around Berwyn Heights Elementary School. Public Works hours of operations remain at 6:30 a.m. to 3:00 p.m. to avoid interfering with peak commuting times; the November Bulletin will feature recycling and refuse disposal reminders, to be followed by a mailer to every household in December; loose leaf collection will be in effect from November 1 to the end of December; and Public Works staff will assist with setting up for Trunk or Treat and with electronics recycling on October 28.

Mayor Jewitt noted that TA Cowles is reporting for Public Works because she is the acting Director until a new director has been recruited. CM Rasmussen noted that the September recycling rate was 23% and the landfill diversion rate 32%.

#### 4. Committee Reports

**Green Team:** Diana Agonoy reported upcoming events for the Green Team and the Recreation Council. The Green Team completed the Town's recertification in the Sustainable Maryland program and the next meeting will be held on October 18. The Recreation Council is hosting the annual Trunk or Treat event, this year co-hosted with College Park, and has recruited the Girl Scouts to help with roasting s'mores at the fire pit. Also coming up are a Town Clean-up day on November 4, Tree-lighting on December 2, and Toys for Tots collection, which concludes on December 15.

TA Cowles explained the difference between the Sustainable Maryland, Certified program and the Sustainable Communities program is that the former promotes green policies at the local level through the University of Maryland Environmental Finance Center and MML and latter provides access to economic development funds for eligible municipalities, corporations and organizations through the Maryland Department of Housing and Community Development. Mayor Jewitt invited Ms. Agonoy to attend the ceremony for Berwyn Heights' Sustainable Maryland recertification at the upcoming MML conference.

**Historical Committee:** Newly-elected Chair Debby Steele Snyder gave the report. The Historical Committee continues to work on its oral history program. It has purchased new recording equipment

and is busy interviewing as many current and former residents as possible. A fall reception on November 12 will feature the unveiling of a historic walking app, produced by the M-NCPPC's GIS section. All are invited to attend and learn how to use the app, which can be downloaded to one's smartphone.

**Neighborhood Watch/Emergency Preparedness:** Co-Chair Mike Attick announced that seats at the upcoming Paint 'n Sip fundraiser are almost sold out. However, anyone may come to watch and enjoy a glass of wine with their neighbors. He thanked Mayor Jewitt for attending recent NW/EP meetings, which are held every first Wednesday of the month. The Committee is in need of new members to carry out all its responsibilities, and is focusing on recruiting volunteers.

**Recreation Council:** Reported under Green Team.

#### 5. Unfinished Business

There was none.

#### 6. New Business

There was none.

#### 7. Citizens Discussion

Mayor Jewitt received a comment about an unfriendly dog being allowed to run off-leash, adding that she is concerned about a number of dogs barking for long periods. She received 2 phone calls thanking the Council for taking up the problem of increased rat sightings and improper disposal of trash. She also noted that Berwyn Heights residents received an election notice for College Park's City Council election on November 7 because the notice was mistakenly sent to the entire 20740 zip code.

CM Rasmussen received another comment about bringing goats to Berwyn Heights to help control invasive species. He then asked MPT Kulpa-Eddy to clarify the relationship between NW/EP and the CERT team. MPT Kulpa-Eddy explained that the Neighborhood Watch started up in the 1990s and added an emergency response function after the 9-11 attacks and the College Park tornado. Prince George's County similarly started to gear up after 9-11, offering community emergency response training to help prepare citizens throughout the County for emergencies. The NW/EP members who took the training then formed the Town's CERT team, which last year became a 501 (c) 3 organization. The Paint 'n Sip event raises money for the CERT.

CM Shields received one comment from a citizen who was glad the Council decided not to acquire the Humvee.

Phil Ventura, 57th Avenue, announced while playing his accordion that he will provide musical accompaniment at the Paint 'n Sip fundraiser. Anyone without plans for Halloween is invited to stop by his home, where many trick or treaters are expected.

Mike Attick, 62nd Avenue, commented that Berwyn Heights may want to check with the City of Greenbelt if they would accept leaves collected here. Currently, the Town takes them to College Park, but is charged a fee. He also commented on the grass at the school property exceeding the 10" height allowed by Berwyn Heights code, on the Town's plans to assist homeowners to dispose of bamboo, on the appropriate size of recycling bins, on the status of issuing a Berwyn Heights ID for CERT members, and the possibility of NW/EP not participating in Halloween patrols.

Debby Steele-Snyder, Pontiac Street, commented that the 5900 block of Pontiac Streets gets very busy with trick or treaters, who get in the way of pass-through traffic and commuter buses. She suggested increasing police presence in this block.

The meeting was adjourned at 8:47 p.m.

## Worksession October 16, 2017

### Executive Session (6:00 – 7:00 p.m.)

Personnel Matter

### Regular Meeting

The meeting was called to order at 7:00 p.m. Present were Mayor Cheryl Jewitt, Mayor Pro-Tem (MPT) Jodie Kulpa-Eddy, Councilmembers (CMs), Patricia Dennison, Christopher Rasmussen, and Gerald Shields. CM Shields arrived at 7:30 p.m. Also present were Town Administrator (TA) Jessica Cowles, Clerk Kerstin Harper and Shade Tree Board Chair Amanda Dewey.

#### 1. Action Items

There were none.

#### 2. Discussion Items

##### **UMD Cooperation on Sustainability**

**Projects:** TA Cowles said she has worked with Green Team Coordinator Amanda Dewey to refine a list of potential projects for cooperation with the University of Maryland following a presentation at the August 7, 2017, worksession



by Andrew Fellows, Community Outreach Program Manager at the University of Maryland College of Information Studies. The revised list incorporates comments from the Council and is divided into 2 subject areas: 1) community engagement and 2) municipal sustainability implementation efforts.

Under community engagement, the Town is looking for innovative ideas on how to better inform its residents and businesses about events and initiatives occurring in the community and to broaden the volunteer base. Under sustainability efforts, the Town's strategic plan and a recently-developed Sustainable Community action plan identify a broad range of sustainability goals, encompassing the environment, economy, transportation, housing, quality of life and land use. A sample of sustainability goals include:

- Reducing the amount of refuse sent to the landfill
- Exploring a regional food waste collection program
- Mitigating the effects of flooding
- Reducing polluted water run-off
- Decreasing litter
- Enhancing preservation of historic homes
- Increasing the tree canopy

With sustainability goals and strategies already well defined, the next step is to find ways to implement the goals, possibly using UMD students and faculty expertise, which may include:

- An assessment of funding amounts and mechanisms to achieve a project
- Tapping into technical expertise through partnerships
- Demonstration of the value of sustainability projects to private property owners

In response to questions, TA Cowles and Amanda Dewey replied that University collaborators could comprise students, faculty and staff. Grant writing expertise is one of the resources from which the Town could benefit in securing project funding. To engage with the University, a donation of \$10,000 to the University of Maryland College Park Foundation was requested. Based on contributions given by similarly-sized municipalities, a contribution of \$5,000 to \$7,000 is recommended. The Town's list of projects would then be "shopped around" to different departments and schools at the University to find interest-

ed partners. There is no guarantee that a good match would be found for all, or any of the Town's projects within the first year of the partnership; however, over time all the projects would be explored.

Further, it is expected that the implementation of a particular project would not primarily fall on the shoulders of Town staff but mobilize community members and organizations interested in the project. In addition, regional partnerships could develop around a project that build momentum and make implementation more likely.

CM Dennison moved and CM Rasmussen seconded to approve a one-time donation of \$6,000 to the University of College Park Foundation for the purpose of a campus-community collaboration on sustainability projects. The motion passed 5 to 0. CM Dennison moved and CM Rasmussen seconded to fund the donation from the unrestricted fund balance. The motion passed 5 to 0.

#### ***Emergency Operations Plan review:***

TA Cowles highlighted the most recent changes in the Emergency Operations Plan (EOP). The Council made additional changes:

Page 8, Planning Facts and Assumptions, last bullet: add instructions on how to get to Doctors Community Hospital at 8118 Good Luck Road.

Page 9, Concept of Operations: add a bullet on requesting assistance from neighboring jurisdictions. Delete bullet 5 because it repeats what is stated elsewhere in EOP. Rephrase bullet 8 to state "the Town will activate its essential personnel policy" instead of "Essential personnel or their designees will be available at all times."

Page 13, Community Emergency Response Team (CERT): This item was flagged for a more detailed explanation of the role of CERT team pending a meeting with NW/EP Co-chair Mike At-tick.

Page 15, Communications, last paragraph: add "or designee" after PIO.

It was noted that the appendices are not for public use because they contain some confidential information. However, all persons who have a designated role in the EOP will receive a complete copy of the plan.

Trash and recycling collection reminders: TA Cowles explained that the Administration Department will initiate an educational effort on trash disposal and

recycling regulations starting with colored, tear-out page in the November Bulletin, followed by an every-door direct mailer in December. Strict enforcement of the regulations will begin in January 2018. Refuse and recyclables not in compliance will be tagged with an explanatory sticker and will not be collected.

MPT Kulpa-Eddy and Mayor Jewitt instead requested that non-compliance be addressed with a Code fine, to prevent rats and other animals from being attracted to uncollected trash bags, which would negatively impact neighbors. CM Rasmussen added that residents setting out refuse too early, as often happens with clean-outs of apartments and garages over a weekend, should also be cited.

***Emergency police vehicle:*** Mayor Jewitt announced she will meet with TA Cowles and Chief Antolik to start discussing whether, and what type of emergency vehicle, the Town may want to acquire in lieu of the Humvee. She will keep Councilmembers informed of any specifics and seek their input if a vehicle is identified. CM Rasmussen said the discussion should start with a review of the mission of the Police Department and the equipment needed to fulfill that mission.

***WSSC proposed rate structures, letter of comment:*** MPT Kulpa-Eddy gave a status update on WSSC's court-mandated rate restructuring efforts. WSSC is holding another round of hearings on a new set of 5 rate structure options. She provided a draft letter commenting on the proposed rates. She explained that the new proposals continue to include a uniform rate for high and low volume water users alike. This rate would be the simplest to implement, but would result in a 30% increase in rates for low volume users, comprising mostly residential customers, while decreasing rates for commercial customers by 20%. The remaining 4 options are different versions of a tiered rate structure based on water usage that would limit rate increases for low-use customers to 10%, as well as the rate decreases for commercial customers to 8% - 12%.

MPT Kulpa-Eddy said her proposed letter recommends WSSC adopt a "4-tier system with a two-person (110 gpd, average) and a 4-person (220 gpd, average) as the lowest price rate levels... [that] best fits the demographic seen in Prince George's County" and Berwyn Heights. While this option is not among the options currently on the table, it is

consistent with usage in the current 16-tier system, and similar to Option 1 in a 2017 Phase 2 Final Report. The tiered system would also promote more conservation of water usage than a uniform rate.

MPT Kulpa-Eddy asked Councilmembers about their preferences prior to sending a letter. Comments on the proposed rate structures are due by October 31. Councilmembers suggested adding information on the percentage of seniors in Berwyn Heights negatively affected by any price increases, supporting a rate structure incentivizing water conservation, and supporting periodic reviews of the rate structure to evaluate their impact. The Council agreed to authorize MPT Kulpa-Eddy and TA Cowles to finalize the letter after attending an upcoming hearing, and submitting it to WSSC prior to October 31. Councilmembers would receive copies of the letter.

Four Cities agenda: The Council identified the following possible items for an October 25 Four Cities meeting: MDOT presentation on the proposed widening of BWI Parkway (MD 295), the Capital Beltway (I-495) and I-270; updates on WSSC rate restructuring, Purple Line and Maglev train.

### 3. Minutes

The Council reviewed the September 18 worksession minutes. On a motion by CM Dennison seconded by CM Shields, the minutes were approved 5 to 0.

### 4. Announcements/ Department Reports/ Citizen Comments

Mayor Jewitt reported that she attended the MML conference in Rockville and participated in a utilities roundtable. Many participants had experienced similar issues with Pepco tree removals as Berwyn Heights had and engaged Pepco in a lively discussion. Mayor Jewitt attended a social media workshop and learned that social media is often the most effective way to reach residents or representatives. Highway User Revenues (HUR) were again a top MML priority, and she gave 2 interviews about how low and unpredictable HUR affect Berwyn Heights. It was suggested to involve residents in lobbying for HUR. Mayor Jewitt attended a sold-out Paint 'n Sip fundraiser, and reminded residents about dos and don'ts during snow storms.

MPT Kulpa-Eddy reported she attended a Maglev open house at Bowie State University which drew many visitors, as well as media representatives and elected officials. Different routes were discussed but the route through Greenbelt Station and Berwyn Heights had been taken off the table. Four remaining options include a no-build option, two

routes following the BWI Parkway, and one following the Penn Line through New Carrollton. She also received a citizen comment about a street sign taken off a post at 63<sup>rd</sup> Avenue and Quebec Street.

CM Rasmussen received comments urging the Council to look for sites for a dog park. Options might include the T-Ball field at Indian Creek trail, an area immediately to the east of Sports Park, and an old Town right-of-way across from the Community Garden. CM Rasmussen updated the Council on the status of renovating his fire-damaged rental property on Ruatan street, where a stop work order was issued because his contractor had neglected to file for a Town permit despite repeated reminders.

CM Shields announced upcoming events and the due date of October 27 for the recycling bin survey. He reported that he called Park & Planning about litter at Lake Artemesia, that he continues to work on the organizations policy, and that Public Works cleaned up Sports Park. He received comments on the Humvee, on a rental property putting out too much trash, on Metro's pedestrian bridge being a patch job, and on placing the focus on getting recycling bins with wheels, but not trash cans. He offered the personal comment that the remaining proposed routes for a Maglev train still present problems for a true high-speed train.

### 5. Town Council Schedule

The Council reviewed the calendar. No changes were made.

The meeting was adjourned at 9:03 p.m.

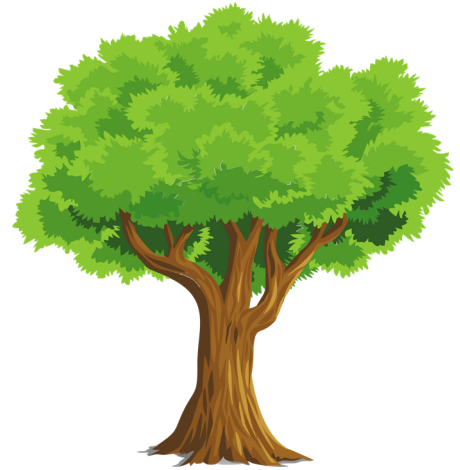

## Town of Berwyn Heights Receives Prestigious Sustainable Maryland Certified Award at Maryland Municipal League Conference

The Town of Berwyn Heights was one of 13 Maryland municipalities honored at the **Sustainable Maryland Awards Ceremony** at the Maryland Municipal League's annual Fall Conference in October.

Berwyn Heights was one of nine Maryland municipalities to originally become Sustainable Maryland Certified in 2014, and the Town successfully became re-certified again this year.



### Highlights of Berwyn Heights' accomplishments include:

- Created a Community Garden, now in its fourth year, with 30 garden plots available to residents.
- Partnered with Ecobeco, an energy efficiency company, to host an energy efficiency workshop for residents concerned about high energy bills and older drafty homes.
- Marked its 20<sup>th</sup> year as a Tree City USA community.
- Installed energy-efficient LED lighting at town facilities.
- Created a Green Team webpage to serve as a sustainability resource center for residents.
- Promoted bicycling by establishing bicycle trails connecting the Town to neighboring communities and to the region's public transportation and tourist hubs, and installing bike repair stations and bicycle racks at Town facilities.
- Hosted a free rain barrel workshop, providing 30 residents guidance on assembling their own rain barrels.

## Live Christmas Tree Safety

It's that time of year, and BHVFD's Christmas Tree Sale Fundraiser is under-way! While live trees have their benefits, if not properly cared for they can pose a fire safety risk. Follow these steps to ensure everyone's holiday is safe and enjoyable!

**Picking the Tree:** Choose a tree with fresh, green needles that do not fall off when touched.

**Placing the Tree:** Make sure the tree is at least three feet away from any heat source, like fireplaces, radiators, candles, heat vents or lights. Make sure the tree is not blocking an exit. Add water to the tree stand. Be sure to add water daily.

**Lighting the Tree:** Replace any string of lights with worn or broken cords or loose bulb connections. Never use lit candles to decorate the tree. Turn off Christmas tree lights before leaving home or going to bed.

**After Christmas:** Get rid of the tree after Christmas. Dried-out trees are a fire danger and should not be left in the home or garage, or placed outside against the home.
