Curbside Leaf Collection

November 4 - December 28 Holidays Excluded

Your Public Works Department offers curbside loose leave collection through the end of December. You may continue to set out leaves in brown paper yard waste bags, to be picked up on yard waste collection days.

Reminders

- Please rake your leaves to the curb or to an existing sidewalk, but NOT into the street.
- Do not mix loose leaves with sticks, rocks, trash or debris, as they can damage the leaf machine.
- Do not mix loose leaves with thick branches. They are collected separately:
- Do not park cars in front of or near leaf piles, as this hampers access by the leaf machine.
- Be advised that it takes approximately 2 weeks to complete a round of leaf collection in the Town.

- Tenga en cuenta que lleva aproximadamente 2 semanas completar una ronda de recolección de hojas en la ciudad

HOMEOWNERS TAX CREDIT

APPLICATION DUE DATE EXTENDED TO JANUARY 1

On September 11, 2019, the Berwyn Heights Town Council approved Ordinance 180 authorizing a Residential Tax Credit Program. Berwyn Heights resident homeowners who have applied and received the State of Maryland Homeowners' Property Tax Credit are eligible to receive up to a 10% credit on their Town real property tax bill. The program has both residency and income eligibility criteria.

Resident homeowners must submit a completed application for the Berwyn Heights Residential Property Tax Credit, along with a copy of both their application for and approval from the State of Maryland Homeowners' Property Tax Credit by 5 p.m. on January 1, 2020.

The Berwyn Heights tax credit application is available on the Town website under <u>Forms/Administration Department</u>. Information about the State's Homeowners Tax Credit program is available at the <u>Maryland Department of Assessment & Taxation website</u>.

WORKSHOP ON COMMUNITY RESPONSE TO A BIOLOGICAL PANDEMIC

DECEMBER 15 | 9:00 AM-1:00 PM | TOWN CENTER

This training workshop will use movie scenes to showcase the *'unrealized'* effects a biological outbreak will have on a community and to prompt discussion amongst attendees as to what planning and preparation needs to be done beyond the basic State Health Department plan to dispense medication.

We will begin with a brief training overview of some known biological agents: their classification, signs and symptoms, and what makes them a threat. The review will be followed by a modified-tabletop exercise using scenes from a movie that accurately depicts the ripple effects a biological outbreak as the scenarios for our group discussions. We will track an unknown biological agent from its initial appearance in 'patient zero' to its explosion as a worldwide pandemic. As the movie progresses, we will stop it, look at the events that have taken place up to that point and discuss what effect these events would have on Prince Georges County and the surrounding areas.

Who should attend this workshop? ... Government officials and other community leaders, law enforcement, fire, first responders, health department and medical personnel, business leaders, CERT members & other community response organizations and citizens... basically everyone!. *If/when this happens, it will truly take a community working together to make it through*.

Worksession (Draft) October 7, 2019

Present were Mayor Pro Tempore (MPT) Jason Papanikolas, presiding, Councilmembers (CMs) Amanda Dewey, Ethan Sweep, and Jeffrey Jay Osmond. Mayor Stephen Isler had an excused absence. Also present were Town Manager (TM) Maria Broadbent, Clerk Kerstin Harper, Election Judges Sharmila Bhatia, Lee Fuerst and Debby Steele-Snyder, as well as developer Jay Endelmancode appellantJason Meier and citizens.

1. Announcements

Mayor Isler was absent due to a medical appointment. MPT Papanikolas, CMs Dewey and Osmond will attend the upcoming MML Fall Conference. BHES sixth graders are at North Bay Adventure Camp this week, supported with funds raised by their teacher Bret Goldstein who rode his bike to the camp. Last Friday, employees enjoyed a staff development day on the skipjack 'Stanley Norman.' The sailboat is owned by the Chesapeake Bay Foundation, which uses it to give educational tours on the Bay.

2. Discussion Items

Vote by mail - Election Judges Report: MPT Papanikolas welcomed Berwyn Heights election judges Sharmila Bhatia, Lee Fuerst and Debby Steele-Snyder. He said the Council is thinking about adopting a vote-by-mail component to the Town Council election process and asked the Board of Election Supervisors to look into it. CM Dewey clarified that there are no plans to replace the current in-person voting system but to add an option for voting by mail.

Chief Election Judge Sharmila Bhatia said the Board of Election Supervisors recently filed a report with the Town laying out concerns the Board has about voting by mail, i.e. sending ballots to every registered voter in the Town through the mail. She said the Town's current election process already makes voting by absentee ballot available on request to all registered voters for any reason. It affords residents the convenience of voting at a time of their choosing in the month prior to the election. The Board's concerns about voting by mail include:

- Ballots and ballot envelopes would have to be redesigned to conform with USPS standards;
- USPS post office serving Berwyn Heights has bad service record. The report includes several examples of customer complaints;
- Challenges with validating ballot signatures during tallying of the vote.

Ms. Bhatia continued the Board recogniz-

es the Council's concern about low voter turnout and provided recommendations to increase voter turnout to include:

- Improve voter education about the Town's form of government;
- Advertise election on social media, e.g. Twitter, Facebook, Next Door, in addition to Bulletin;
- Post banners and signs about the election along Town streets;
- Send out election mailers;
- Increase door-knocking by candidates;
- Utilize Facebook to advertise the election and possibly live-stream candidates' night.

In the ensuing discussion, the Council agreed with the Board's recommendations for increasing voter turnout but had questions about the process. Ms. Bhatia, Clerk Harper and TM Broadbent sought to answer their questions about signature validation on mail-in ballots; the role of the Prince George's County Board of Elections; voting by absentee ballot; and appointment of the Board of Election Supervisors.

CM Sweep and CM Osmond expressed skepticism whether the Town can fit all the pieces together to implement voting by mail in time for the next election and would prefer to spend the money on voter education and outreach. CM Dewey said if it is not possible, she would like the Town to publicize the absentee voting option. TM Broadbent asked Councilmembers to e-mail her their concerns, and she will attempt to provide answers for the November 4 worksession.

Variance 94-2019 8906 58th Avenue: MPT Papanikolas welcomed property owner Jay Endelman, who plans to build a new single-family home at 8906 58th Avenue. Mr. Endelman was invited to explain the variance request. The Council will hear the variance tonight but will not make a formal decision until the next Town meeting.

Mr. Endelman said he needs two variances to build a house because his property does not meet the current development standards: 1) zoning regulations now require each lot to have a minimum of 6,500 square feet, but his property has only 6,315 square feet; 2) each lot must be at least 65 feet wide along the front building line, while his property is only 50' wide. Mr. Endelman said this lot was created by a deed of re-subdivision at a time when development standards were different, and the lot size and frontage would have been acceptable. He requested Town support for the variances.

TM Broadbent noted that parking opportu-

nities along the property's frontage are limited. The site plan calls for a driveway that can accommodate only two vehicles parked in a line. A second driveway might be an option to create more offstreet parking. The Council expressed concerns about reducing stormwater runoff and maintaining shade trees. Mr. Endelman replied his current plans, approved by the County, call for gutters and downspouts to manage stormwater and the planting of a pin oak and an ornamental cherry. No large shade trees will be removed. The Council suggested that Mr. Endelman consider adding more sophisticated stormwater management facilities and plant another shade tree instead of the cherry.

TM Broadbent said the Council will take Mr. Endelman's variance request under advisement but will likely request environmental improvements before recommending approval to the Board of Zoning Appeals. She asked, and Mr. Endelman agreed to provide the Town with land-scape plans showing additional stormwater management features and trees prior to the Town meeting.

Code appeal – 5716 Berwyn Road: MPT Papanikolas welcomed Jason Meier, owner of the rental property at 5716 Berwyn Road, to make appeal concerning his rental license renewal application. The Council will take testimony tonight but make a decision at the next Town meeting. TM Broadbent recommended that Mr. Meier be allowed to present a timeline of events relevant to his appeal, followed by Code Compliance Director Goodwin's presentation of a timeline and applicable law.

Mr. Meier stated that he bought his house in 2007 and resided there until 2017. He relocated to Washington, D.C. and now rents the house. He is appealing the validity dates of his current license, which was issued on August 21, 2019, but has a licensing period of July 1, 2019 - June 30, 2020. He disputes a license can be valid prior to its date of issuance and completion of licensing requirements such as passing an inspection and obtaining a lead-free certificate. He thinks his license should be valid from the date of issuance, August 21, 2019 - August 20, 2020. He has spoken with TM Broadbent on August 29 about the matter but was informed that the dates would not be changed. He also stated his complaint at the last Town meeting and was advised to file this appeal.

Mr. Meier further stated he believes Berwyn Heights' rental license renewal process is 'broken' and does not permit

enough time to complete all requirements for license renewal before the old license expires. He received an email on May 31 notifying him to submit his application and fee by June 28, two days before the license expiration date, June 30, 2019.

Director Goodwin explained all rental homes operate on fixed licensing schedule: if a rental license was valid between July 1, 2018 and June 30, 2019, the same licensing period would apply for following year. Second, if the Town were to issue a license valid between August 21, 2019 and August 20, 2019 it would violate Ordinance 120 Section 4D, which requires that licensing periods run from the 1st day of the month of issue. Ordinance 120 Section 4D also requires a rental homeowner to apply for a license renewal 20 days prior to the expiration date, leaving time for processing the application and performing an inspection. Lastly, had this year's license not been made effective for July 1, Mr. Meier would have operated his rental home without a license and could have been fined.

Mr. Meier said he does not have an issue with the process as it is laid out in the Ordinance but the Town, in his opinion, did not follow it. If the license must start on the first of the month, he would like the Town to issue a license with a start date of September 1 and an end date of August 30. The Council responded making the following points:

- The Town is bound by Ordinance 120 to follow a certain process;
- It is the home/ business owner's obligation to know what the rental licensing process is and to ensure that the rental home is inspected and licensed prior to expiration of the license, regardless of whether there was a notification problem;
- Mr. Meier had the same issue last year and might have filed his license renewal application earlier this year to avoid the problem.

After further discussion, CM Osmond said the Town cannot violate its Ordinance to accommodate Mr. Meier's request but apologized for any miscommunication on the part of the Code Compliance Department and the length of time it took to renew the license. The Town will review the notification process and make any necessary changes. Mr. Meier is encouraged to submit his license renewal application at least 20 days prior to its expiration next year, as required by Ordinance 120. Mr. Meier accepted the apology and withdrew his appeal.

Education Advisory Committee funding request: CM Dewey said the BHEAC will hold a series of listening sessions to better understand existing educational needs, concerns and initiatives. The BHEAC will invite parents with schoolaged children and other education stakeholders, provide translation service, as well as light refreshments. The BHEAC asked if the Town might be willing to support this activity. The Council agreed to give up to \$300 for the BHEAC listening sessions from the Town Council's outreach fund.

Legislative dinner date: The Council set November 6 as the first choice for the Town's legislative dinner, and November 12 and 14 as alternative dates.

Employee appreciation lunch date: Staff proposed December 13 as the date for the annual employee appreciation lunch. The Council agreed.

M-NCPPC correspondence: CM Sweep moved, and CM Osmond seconded to table the item to the November 1 worksession. The motion passed 4 to 0.

3. Minutes

CM Sweep moved, and CM Osmond seconded to approve the September 9 worksession minutes. The motion passed 3-0-1, with CM Dewey abstaining. Approval of the September 16 worksession minutes was tabled to October 21. The September 11 Town meeting minutes were distributed.

4. Department Reports

CM Sweep reported that road construction continues but is nearing the end. He thanked residents for driving carefully in construction zones. He cautioned residents about cutting their grass too short or having open fires in their yards because the area is experiencing a drought. TM Broadbent added that the planned tree planting has been postponed to the spring.

Phil Ventura, 57th Avenue, said it may be advisable for residents to water their homes' foundations because the prevailing clay soils shrink during droughts and may cause cracking of foundations. He also wondered whether remedial street work was done at the contractor's expense. He was assured it was.

CM Dewey reported that the Green Team hosted a very successful and fun pet event last Saturday. Two cats and 2 dogs were adopted, 11 dogs were microchipped and some 40 pets vaccinated. The vendors who came out to participate were not disappointed. CM Dewey also worked on the resident survey, on a tree planting plan and with the Walkable, Bikeable Berwyn Heights Task Force.

5. Town Council Schedule

The Council reviewed the upcoming Town Council schedule. No changes were made. An M-NCPPC planning official will attend the October 21 worksession to brief the Council on the new zoning regulations.

6. Citizens Discussion

Phil Ventura thanked CM Osmond for apologizing for mis-steps in the code enforcement process and MPT Papanikolas for defending the Town's election process. Further, he said that the recycling market is becoming increasingly restrictive. Many recycling processors are no longer accepting glass containers and are asking collectors to sort paper and cardboard items.

TM Broadbent replied the Town has to go by what the Prince George's County recycling facility does and they have not made any of the changes Mr. Ventura describes. CM Dewey added this is why the Green Team always recommends consuming less first.

Blake Dewey, Quebec Place, commented that opportunities for voting should be increased even if it means that traditional processes would have to be changed. He encouraged the Town to advertise and expand absentee voting as a way to give residents more opportunities to vote.

The meeting was adjourned at 9:30 p.m.

own Meeting October 9, 2019

The meeting was called to order at 7:00 p.m. Present were Mayor Stephen Isler, Mayor Pro Tempore (MPT) Jason Papanikolas, Councilmembers (CMs) Amanda Dewey and Ethan Sweep. CM Jeffrey Jay Osmond had an excused absence. Also present were Town Manager (TM) Maria Broadbent, Clerk Kerstin Harper, Treasurer Michelle Rodriguez, Chief Kenneth Antolik, Detective Daniel Unger, Public Works Director Kenneth Hall, Code Compliance Director Hollyce Goodwin, BHVFD Representative Matt Huddle and citizens.

1. Approval of Agenda

Mayor Isler requested that the Public Works report be moved up before the Administration report. MPT Papanikolas moved to approve the amended agenda. CM Sweep seconded to approve the agenda. The motion passed 4 to 0.

2. Ceremonial Items

CI-12 Domestic Violence Awareness Month: Mayor Isler read a proclamation calling on everyone to prevent acts of domestic violence and support victims of these crimes. TM Broadbent added that

this is a statewide initiative promoted by the Berwyn Heights Police Department (BHPD).

3. Approval of Minutes

CM Dewey moved, and MPT Papanikolas seconded to approve the September 11 Town meeting minutes. The motion passed 4 to 0.

4. Mayor's Report

Mayor Isler thanked CM Dewey and the Green Team for a wonderful pet event that was held last Saturday. Several people adopted pets including a BHPD intern. He was surprised to find that one of his cousins is living in this area as a dog trainer and participated in the event. Mayor Isler also reminded residents to be mindful of students being back in school and to drive carefully near school buses. CM Dewey thanked Mayor Isler and MPT Papanikolas for judging the pet costume and talent contests.

5. Department Reports

Public Works: Director Hall introduced Foreman Cardenas, who may give the Public Works reports in the future. Director Hall reported that the streetsweeper will be in Town October 21-25. Streets north of Pontiac Street will be swept on Monday of that week and those south of Pontiac Street on Tuesday. The remaining days will be for cleaning up missed areas. Residents are requested to park off-street where possible. The new recycling containers are in the process of being delivered to residents and the work should be finished by the end of next week. The street repair work is also drawing to a close with perhaps a few touchups remaining.

CM Dewey thanked Director Hall and his crew for getting the Town Center parking lot repaved, just in time for the pet event. TM Broadbent said Public Works also cleaned up debris from the removal of several trees in the back of the Town Center. One of the large oaks was removed because it was dead. Residents are encouraged to have their trees checked out if they already have brown leaves. They may be dying due to the recent drought. Planting of new trees in the Town right-of-way has been postponed to the spring because of the drought. Residents can request to have the Town plant trees on private property by contacting the Town office if they are willing to maintain them.

Foreman Cardenas said the Public Works Department is getting everything ready for curbside leaf collection in November. For now, residents are requested to continue to place leaves into brown paper yard waste bags for disposal. He also asked residents to drive carefully around trash trucks when crewmen are collecting refuse. The truck drivers are not always able to see approaching vehicles. The new recycling containers that are being delivered come with information about what to do with the old recycling bins. The information packet comes with stickers for the old recycling bins to mark them for yard waste.

CM Sweep cautioned residents about having fires in their yards because of drought conditions. He also thanked TM Broadbent for arranging a staff retreat on the Chesapeake Bay Foundation's skipjack. He enjoyed learning about the environmental improvements in the Bay and Chesapeake Bay history. TM Broadbent said the skipjack was the iconic boat of the Chesapeake Bay but only a few of them remain. The excursion was financed from a rebate staff earned by using health insurance judiciously.

Administration-Treasurer's Report:

Treasurer Rodriguez gave the Treasurer's report for September. She said that revenues and expenses have been normal. The Town was able to sell an old pickup truck for \$6,200 via online auction. The money was deposited in the vehicle replacement reserve. A Town ride-on mower will go on the auction block tomorrow. Further, transfers to reserves from FY 2019 revenues were processed, including the infrastructure reserve, the vehicle replacement reserve and the NW/EP trailer reserve. Responding to CM Dewey, Treasurer Rodriguez said that the audit is on track and is due to the State by the end of October. TM Broadbent added that the auditors may present to the Council in November.

Town Manager's Report: TM Broadbent reported that this will be the last Town meeting at which department directors will give their monthly reports in person although the reports will still be provided to Council and entered into the public record. Instead the directors will give a status report on their projects at the second worksession of the month. The project list will be reformatted to show the origin of each project and to be published on the Town website. The Police Chief may continue to give a monthly report to satisfy reporting requirements, and other directors may come to the Town meeting on a quarterly basis.

Code Compliance: Code Director Hollyce Goodwin gave the code activities report. Currently there are 283 rental units, 210 of them active. The Department issued 7 rental licenses and performed 17 inspections and 3 reinspections. Further, the Department is-

sued 13 clean lot violations and a few courtesy notices. Most clean lot violations pertained to vehicle storage issues. Residents are reminded that vehicles having no tags or expired tags must be covered with a vehicle cover or stored in a garage.

Director Goodwin said the Department continues to process business licenses. Of 110 applications sent to Town businesses, ninety have now been returned. Compliance stands at approximately 80%. Businesses that fail to submit a license application are subject to an initial \$50 fine and then a \$25 fine per month. The Department also issued 2 building permits, 5 dumpster permits and 1 right of way permit.

The Code Department continues to monitor the McDonald's reconstruction, which should be finished, and the restaurant reopened in mid-November. At the moment, the construction site is chaotic as the contractors are rushing to get the project done. Last Saturday, the Code Department took part in a multi-cultural day hosted by the Police Department. There was food and music and it provided a good opportunity to engage with residents.

Phil Ventura, 57th Avenue, asked whether the Code Department has an update on removal of a dead oak tree that grows in a resident's yard. Director Goodwin said the Department sent out notices to a number of homeowners asking them to remove dead trees giving them a period of 60 days to comply. Most property owners have complied, some have asked for extensions. She has not heard anything from this property owner and will check into it.

CM Dewey asked whether homeowners are required to use a certified arborist to cut down large trees and whether the Town can make sure they actually do. TM Broadbent said that homeowners are required to use a Maryland-licensed tree care expert, but not necessarily an arborist. The Town does not enforce tree care licensing. Residents are encouraged to make sure that the contractors they hire are licensed and insured. Licenses can be looked up on the Department of Labor website at https://www.dllr.state.md.us/pg/.

Parks, Recreation, Education & Civic Affairs: CM Dewey reported that she has been working on the resident survey and is expecting submissions of survey questions from the staff and Town organizations by next week. She also attended the second meeting of the Walkable, Bikeable Berwyn Heights Task Force (WBBH). The group is doing a lot of research and discussing interesting ideas. She is look-

ing forward to hearing their recommendations. She thanked all those who helped with, and came out for, a great pet event last Saturday.

Public Safety/ Berwyn Heights Volunteer Fire Department; Matthew Huddle reported that the BHVFD was awarded a \$70,000 FEMA Assistance to Firefighters Grant for two self-loading power stretchers and two new stair chairs for the ambulances. This equipment should reduce the potential for injuries while loading patients into ambulances. The Department is waiting for updates on the new rescue squad that is in the process of being built. Fundraising letters have gone out to the residents. This will be the only way the Department contacts residents. No calling or door-to-door soliciting will take place. The BHVFD has received the Town's donation and appreciates the support.

In response to TM Broadbent and CM Dewey, Mr. Huddle said the Department does not track fire danger levels. However, the County Fire Department works with the Department of Natural Resources (DNR) to publish fire risk warnings. Prince George's County does not allow bonfires and burning of leaves in open areas, but fires in fire pits and hearths are permitted. Currently, he recommends not burning anything outside.

Police Department: Detective Unger gave the police activities report as Chief Antolik was on vacation. In September there were 8 Part I offenses: 2 assaults, 1 burglary and 6 thefts, which is higher than the 5-year average of 6.8. The Police issued 118 State and municipal citations, made 3 arrests, impounded 4 vehicles, and patrolled approximately 3,006 miles.

In response to questions, Detective Unger said to prevent thefts of packages delivered to the doorstep, residents might consider getting a video doorbell that is connected to one's smartphone. They act as a deterrent and if there is a theft, police can be provided some documentation. For any internet purchases made through Craig's List, Letgo, Offerup and similar vendors, BHPD has established safe exchange zone in the BHPD parking lot that has video surveillance.

6. Committee Reports

Education Advisory Committee: CM Dewey said the BHEAC will hold a series of listening sessions during its meetings, starting on October 26, 6:00 p.m. In this session, students and parents of students in middle and high school, public and private school are invited to attend the sessions to share their needs and concerns. Future sessions will focus on dif-

ferent age groups and topics. The next ances to build a new house on his lot. His regular meeting will be on November 25. property does not meet current develop-

Green Team: CM Dewey said the Green Team will participate in Trunk or Treat with a telescope stargazing activity and after Halloween trick-or-treating hold a special Town cleanup on November 2. There will be refreshments and prizes for maintaining a clean perimeter on one's property or participating in the cleanup.

Historical Committee: Clerk Harper reported that the Historical Committee continues to prepare for its fall reception on November 10. This year the BHHC will celebrate the 100th Anniversary of the Berwyn Heights Company with the dedication of a historic marker, a slideshow and a meet & greet of descendants of the people who ran the Company.

Neighborhood Watch/Emergency Preparedness: There was no report.

Recreation Council: President Susan Jones reported that the Recreation Council hosted a successful series of summer concerts at Lake Artemesia. There are plans for doing it again next summer expanding it to include College Park. The Recreation Council also intends to start a singer/ songwriter program and invites anyone to contact them if interested in participating. The ice cream social was very well attended by a diverse set of residents. Trunk or Treat is scheduled for October 19, with setup at the Community Center starting at 6 p.m. There will be prizes for best decorated cars and costumes. On November 3, 3:00 p.m., the 'Turtle Heroes' will give a bluegrass concert at the Town Center, and on December 7, 6:00 p.m., the annual tree lighting celebration will be held in the Senior Cen-

This Friday at 7:00 p.m. will be the first showing of a movie by a newly established movie club. The club plans to convene every Friday evening in the G. Love Room to watch and discuss a movie, while covering a wide selection of genres. CM Dewey said people should also watch out for Trivia Night, which will come back early next year.

7. Unfinished Business

There was none.

8. New Business

Variance 94-2019 8906 58th **Avenue:** TM Broadbent said the applicant for the variance wants to develop a lot at 8906 58th Avenue and attended the last worksession to explain his situation.

Director Goodwin said that the property owner, Jay Endelman, needs two variances to build a new house on his lot. His property does not meet current development standards. He is requesting variances of 185 square feet of net lot area and 15 feet for the front building line to meet the minimum requirements of 6,500 square feet of net lot area and 60 feet of front building line width. At the last worksession, the Council and staff expressed concern about parking limitations, storm water management facilities and lack of shade trees at the property and set the following conditions for approval of the variances:

- Addition of two dry wells in the front and rear of the dwelling; and
- Addition of a large shade tree in the southwest corner of the property.

Both changes are to be shown on a revised landscape plan that will be submitted to County for the record. Mr. Endelman agreed to make those changes and staff recommends approval.

CM Dewey asked whether the property owner might also be asked to add rain barrels and/ or a rain garden as additional storm water mitigation devices. TM Broadbent advised against it as Mr. Endelman has already gone beyond the County's requirements for storm water mitigation. Further, some homeowners will not want to maintain rain barrels or a rain garden, limiting their utility if the house is sold.

CM Sweep moved to recommend approval of Variance 94-2019 to the Board of Zoning Appeals with the above conditions, plus adding rain barrels at his discretion. MPT Papanikolas seconded. The motion passed 4 to 0.

Citizen Discussion

Darald Lofgren, 58th Avenue, said two lots adjacent to the Public Works yard are vacant and may be available for purchase. When he was on the Council, he had supervision of the Public Works Department and knows that it would be beneficial to have more space for all the trucks and equipment. The vacant lot may even be large enough to accommodate a new Police Department. He suggested the Council look into purchasing it if available. CM Sweep said he believes the previous Council discussed the purchase with the owners, but they wanted more money than the property is worth. TM Broadbent offered to talk to the owners.

Phil Ventura said that the new rain barrels installed around the Town Center overflow during heavy rains with water

splashing down next to foundation. The old barrels were designed to slowly drain through a hose directed away from the building.

Blake Dewey, Quebec Place, asked the Council to consider supporting a repeal of the pit bull ban instituted in 1997 that is now being taken up by the Prince George's County Council. A 2003 task force studied the effects of the ban and found that it is expensive to enforce, has few public safety benefits, and reduces the ability of the County's Animal Control agency to effectively enforce animal regulations in other areas, such as leash laws and animals at large. The task force recommended a repeal of the ban to free up resources and shelter space. The saved money could be used for other animal control activities, including promoting responsible dog ownership.

CM Sweep said he personally agrees with a repeal of the ban and believes that pit bulls are not innately more vicious than other dogs. A CDC study about dog bites has confirmed this. The County Council is expected to take the issue up in the next legislative session and he would be in favor of this Council writing a letter to support repeal. TM Broadbent suggested adding it to the agenda for the legislative dinner.

Susan Jones said the Prince George's Parks & Recreation Department recently renovated the stage at Lake Artemesia. Performers would like to have a roof put onto it to keep the sun or rain off. She has talked to a number of people about a roof, including the park ranger, and most support the idea. She asked whether the Council could raise the issue with the Parks & Recreation Department. TM Broadbent said she would be happy to do this.

Darald Lofgren said when Lake Artemesia Park was established, the Town told Park & Planning that it wanted the park to be a quiet recreational area. Asking them to make upgrades to the stage conflicts somewhat with the original intent. It may bring more concerts and people to the Lake, who would most likely be parking in Berwyn Heights.

The meeting was adjourned at 8:33 p.m.

Worksession (Draft) October 21, 2019 Present were Mayor Stephen Isler, Mayor, Councilmembers (CMs) Amanda Dewey, Ethan Sweep, and Jeffrey Jay Osmond. Mayor Pro Tempore (MPT) Jason Papanikolas had an excused absence. Also present were Clerk Kerstin Harper, Assistant to the Town Manager Yvonne Odoi, and citizens. Town Manager (TM) Maria Broadbent had an excused absence.

Announcements

The Education Advisory Committee (BHEAC) will hold a listening session/ focus group for middle and high school students and their parents on October 28. Councilmembers had fun judging the Trunk or Treat event last Saturday. The Police Department and the Volunteer Fire Department participated with a creatively decorated car and truck.

Discussion Items

MNCPPC zoning update: Mayor Isler welcomed Master Planner Chad Williams to give an overview of the Prince George's zoning rewrite. Mr. Williams said the County adopted a new zoning ordinance and subdivision regulations for the first time in 40 years. The process took 4 1/2 years but will not be effective until a county-wide map amendment has been approved about a year from now. The map amendment will apply the new zones to properties.

The new zoning ordinance has simplified the land uses found in the County from around 1200 to around 250, which are more flexible and easier to use. They are intended to diversify the County's tax base and bring in new investment. Design standards were upgraded to ensure more high-quality development.

A Guide to New Zones, adopted by the County Council, prescribes the process by which new zones will be applied to the old zones. For the most part, the zones will remain the same with only about 3% being rezoned. The rezoned areas are mixed-use zones, such as transit-oriented development and activity centers, as Well a Route 1 Innovation Corridor, which includes Route 193 to Hannover Parkway.

The Planning Department is doing outreach to inform everyone about the map amendment through website, social media and open houses. The nearest event to Berwyn Heights is on November 7 at College Park Airport. In addition, planning staff will give a briefing to any municipality or civic group that requests it. In March 2020, the Planning Board and County Council will hold a joint public hearing on the proposed zoning map, at which people can testify. Through the summer, the

County Council will hold a series of worksessions on the map amendment and then a 2nd public hearing around September, with a final approval anticipated for late October early November 2020. After that the map amendment will go into affect

Mr. Williams then demonstrated the proposed new zone comparison map, which be accessed ingpgc.pgplanning.com. Here people can see the new zone for their property or neighborhood using a zoning swipe tool or typing in an address. In Berwyn Heights proper, there are few changes: the residential zone will remain residential, designated as RS65; the business district will become commercial general office or CGO; the light industrial properties along Ballew Avenue will become an industrial employment or RE zone; and open space will become agricultural preservation. To the north of Berwyn Heights, the metropolitan center will become regional transit district and with high intensity zoning. Greenbelt Station and Beltway Plaza will become mixed use and commercial zones, respectively.

Census 2020: CM Dewey requested the Council to discuss the decennial census that will take place in spring 2020. The Census will determine government representation as well funding for a variety of federal and local programs. It is therefore important to get as close to a complete count as possible. Prince George's County calculates that for every person not counted it loses approximately \$18,000 over 10 years. CM Sweep noted that there is an under-count of young children in Prince George's County, which results in schools being underfunded. Further, residents should be assured that the Census is strictly confidential and personal data will be kept private.

The Council discussed ideas on how to increase participation in the 2020 Census. Ideas included:

- Town hosting a Census Day event on April 1, and making computers in the Senior Center available to take the Census online;
- Encouraging local schools to hold a Census Day of their own allowing parents to use their computers, while serving a light meal and providing activities for students; CM Dewey offered to raise the idea with the PTA and the BHEAC.
- Developing a social media campaign around the Census;
- Town staff wearing Census 2020 tshirts and putting stickers or flags on their trucks;
- Town departments coming up with additional ideas to advertise the Cen-

sus:

 Town advertising Census jobs opening now.

In addition, the Council agreed that Census publicity should highlight the different ways in which the Census can be taken (online, by mail, and in door to door survey), as well as the starting and end dates. All Census related information can be found at the website www.census2020.gov. The Council plans to continue discussing the Census at future worksessions.

Legislative Dinner agenda: Mayor Isler said the Town's legislative dinner is scheduled for November 6, 6:00 p.m. at the Greenbelt Crowne Plaza hotel. A draft agenda has been provided. It includes a list of Berwyn Heights priorities, e.g. Sports Park, Dog Park, Census 2020 Complete Count. Educational Involvement, and Stormwater Management Projects. CM Dewey asked to add Pepco vegetation management legislation to the agenda, and Mayor Isler the repeal of the pit bull ban. Assistant to the Town Manager Odoi said the Administration Department would like to discuss possible state funding for Town Center improvements, including a new roof, elevator replacement, emergency generator power panel reconfiguration, and adding bathrooms for G. Love Room. The Council had no objec-

Four Cities agenda: Mayor Isler said the next Four Cities meeting will take place on October 23 in New Carrollton. The Town of Berwyn Heights portion of the agenda has the repeal of the pit bull ban. No other items were added. CM Dewey asked whether BHPD could provide a short memorandum on Berwyn Heights' purchase of hybrid police interceptors, which New Carrollton plans to bring up.

MML debrief: CM Osmond reported that he took many of the Academy's core courses towards certification. He found the workshop on the Structure of Municipal Government most interesting. He learned that a municipal government does not always function the way it is organized. CM Dewey said she also took this workshop. What stood out to her was the discussion on the municipal charter, its import and meaning and the difference to other parts of the municipal code. She also attended a workshop on walking and biking infrastructure, which gave insight on the different types of amenities available and opportunities for learning what other municipalities are doing in this area.

Town Council -e-newsletter

Mayor Isler said he did not have time to work on the newsletter because of the demands of his teaching job. He will strive to compose a newsletter for November.

Minutes

The Council reviewed the September 16 worksession. CM Sweep moved, and CM Dewey seconded to adopt the minutes. The motion passed 4 to 0.

Department Reports

Mayor Isler thanked everyone who came out for Trunk or Treat. Upcoming events include the Police Department's 'Cocoa with a Popo' community event and the Tree Lighting. He reminded drivers to slow down for walkers and bikers, and bikers to obey the traffic laws.

CM Sweep said he attended the Trunk or Treat event and was impressed by the elaborate decorations of the cars. Further, there was an incident this morning during which a driver swore and spat at a Public Works employee because she could not pass a crewman who was collecting the trash. He finds this behavior unacceptable and asked everyone to be patient when being held up by trash trucks.

CM Dewey said she had fun at Trunk or Treat and saw many cute costumes. Prizes went to a 'Banana' as the funniest, a 'Unicorn' as the cutest, and a 'Skeleton' as the scariest costumes. Upcoming events include a special after-Halloween Town cleanup, where prizes will be awarded for most trash collected. For this event, the Green Team is partnering with the Volunteer Fire Department to dispose of used jack-o-lanterns. Participants can drop their pumpkins from the fire truck onto a tarp if they make a donation to the BHVFD. The smashed pumpkins will be composted at the community garden. In addition, the Green Team will sponsor a social media contest about keeping Halloween green. CM Dewey concluded with an announcement of upcoming events.

6. Town Council Schedule

The Council reviewed the upcoming Town Council schedule. No changes were made.

7. Citizens Discussion

Phil Ventura commented that he always gets a lot of trick or treaters on Halloween. This is one of the events in which Latino families like to participate. Many children are dressed in home-made costumes reminding him of the olden days. Mr. Ventura also noted that TM Broadbent announced at the last Town meeting that department directors will no longer attend every Town meeting but may attend quarterly. He cautioned the Council to not allow such decisions to be made for them. Residents like to see the directors and hear from them directly.

Mayor Isler and CM Dewey replied that

Councilmembers were apprised of the proposal before the Town meeting and gave their approval, and also discussed the proposal at a previous worksession. It was felt that the reading of statistical reports does not tell the Council a lot about what is being accomplished. Instead, the directors will be asked to attend worksessions to give updates on projects they are assigned to carry out based on the Council's priorities. If residents have a concern or a question about a department issue, they would like a director to address, the director can be asked to come in and report. If the Council concludes that the new arrangement does not work, it can always be changed.

The meeting was adjourned at 8:35 p.m.



Live Christmas Tree Safety

It's that time of year, and BHVFD's Christmas Tree Sale Fundraiser is underway! While live trees have their benefits, if not properly cared for they can pose a fire safety risk. Follow these steps to ensure everyone's holiday is safe and enjoyable!

Picking the Tree: Choose a tree with fresh, green needles that do not fall off when touched.

Placing the Tree: Make sure the tree is at least three feet away from any heat source, like fireplaces, radiators, candles, heat vents or lights. Make sure the tree is not blocking an exit. Add water to the tree stand. Be sure to add water daily.

Lighting the Tree: Replace any string of lights with worn or broken cords or loose bulb connections. Never use lit candles to decorate the tree. Turn off Christmas tree lights before leaving home or going to bed.

After Christmas: Get rid of the tree after Christmas. Driedout trees are a fire danger and should not be left in the home or garage, or placed outside against the home.





Capitol Asset Recycling collects all lights, and then breaks them down through smelting or shredding to recover raw commodities. These raw commodities are then used to create roofing and construction materials, piping, car batteries, other electronics, lead wheel weights, flatware, jewelry, and more!



If you are an Air BnB or other short term rental provider, please be aware that as of October 1,

2019, you are no longer permitted to provide this service in Prince George's County **unless** you apply for a Short Term Rental license from the county. Currently, you will also be expected to apply for a rental license in Berwyn Heights. Some highlights from the new legislation:

- \$150.00 annual fee for Prince George's County Short Term Rental License.
- You may no longer advertise as a short term rental, if you do not reside in the Air BnB property.
