## **Residential Flood Gate Relief Program**

This Program seeks to assist Berwyn Heights homeowners whose residences are susceptible to extreme risk of intense stormwater flooding. Its focus is to provide these homeowners with one (1) flood gate (a temporary barrier to seal off the doorway and prevent floodwater from entering), in order to help protect residents' health and well-being.

Household size and income will inform how flood gates are distributed. This will assist the Town in helping fund as many residences as possible, by allowing appropriate integration of the Town's federal *American Rescue Plan Act* (ARPA) award and the Town's General Fund budget.

Application: To apply, the applicant must be the owner of the property located in the Town and must:

- ✓ Complete the application in full.
- ✓ Provide attestation explaining when the flooding occurred, where, extent of damage, etc.
- ✓ Sign the *Release and Hold Harmless Agreement*, below.
- ✓ Provide an attestation of income to be used in processing.

### Other information:

- Approval of applications is determined by a Town of Berwyn Heights ARPA advisory board, composed of two elected officials and the Town Treasurer.
- Application review and approval shall follow ARPA guidelines, Title VI and language access laws. (Please contact Town Clerk Melanie Friesen at (301) 474-5000 (or mfriesen@berwynheightsmd.gov) to request assistance in your preferred language).
- Questions regarding the application process should be directed to Town Manager, Kyle Snyder at (301) 474-500 or ksnyder@berwynheightsmd.gov.
- Funding is subject to appropriation by the Town Council.
- Recipients use of all products must comply with existing law and codes.
- The property owner shall be responsible for ensuring the products are properly installed and maintained.
- Eligibility requirements and "Other information" (above) may be changed at any time by the Town.
