Eligibility Criteria

- **Eligible expenses must be incurred on or after August 10th, 2022.**
- Work must be completed before receiving reimbursement. The Town encourages review of the application before the work is done to verify eligibility.
- Applicant must provide documentation of eligible expenses. Examples of "eligible expenses" includes the purchase and installation of:
 - ✓ Hurricane impact-rated permanent glass protection materials or floodproof windows
 - ✓ Custom ground floor or basement window wells (central drain connected to an outside drain)
 - ✓ A flood alert system
 - ✓ A sump pump battery backup to provide protection against power outages
 - ✓ Impermeable (water resistant) material around foundations
 - ✓ An earthen berm (a small hill built to divert runoff)

For a full list of eligible expenses please contact the Berwyn Heights Town Office.

Required Application Attachments

- Applicant must provide photographic and/or other evidence that flood prevention measures have already been installed.
- Copies of applicable permits and approvals must be submitted with the application.
- Applicants must confirm that their mitigation project and/or installation has not adversely affected neighboring properties by changing stormwater flow.
- Documentation of eligible expenses incurred.
- Proof of flood and homeowner’s insurance.

Evidence of Stormwater Flooding

Only residences that have experienced stormwater flooding are eligible to participate in this program. The Environmental Protection Agency defines “stormwater runoff” as water generated from rain and snowmelt events that flow over land or impervious surfaces, such as paved streets, parking lots, and building rooftops, and does not soak into the ground. Flooding from other sources (e.g., groundwater) are not eligible for this grant. Groundwater is “fresh water (from rain or melting ice and snow) that soaks into the soil and is stored in the tiny spaces (pores) between rocks and particles of soil.”

Note: This mitigation grant program operates by reimbursing eligible homeowners (dollar for dollar) 50% of the costs of these efforts, with a maximum grant not to exceed \$7,500.

Federal ARPA monies are being used to provide this grant program to you. Appropriate care should be used to prevent potential need for investigation of submitted claims.
