The annual business and operating license fee for any association, business entity or establishment, commercial or residential property management association, corporation, entity or partnership, industrial, institutional, retail or service establishment, limited liability association, corporation or partnership including professional associations, corporations or partnerships operating within the corporate limits of the Town of Berwyn Heights is based on the following Gross Receipt Fee Schedule.

* The license fee for businesses whose first day of operating within the Town of Berwyn Heights falls between January 1st – June 30th shall be one-half of the above gross receipts fee for that year.

FILING YOUR BUSINESS LICENSE APPLICATION OR PAYMENT OF YOUR LICENSE FEE IS DUE UPON RECEIPT. YOUR ACCOUNT WILL BE CHARGED A “LATE FILING OR PAYMENT PENALTY OR BOTH” OF \$50.00 AFTER 30 DAYS AND \$25.00 FOR EVERY MONTH OR PORTION OF A MONTH THEREAFTER.
