QUALIFICATIONS:

RESIDENT OF THE TOWN, REGISTERED VOTER IN PRINCE GEORGE'S COUNTY OR THE TOWN OF BERWYN HEIGHTS.

RESPONSIBILITIES:

PARTICIPATING IN A COURSE OF TRAINING TO BECOME FAMILIAR WITH THE TOWN'S ELECTION PROCESS AND LEGAL FRAMEWORK STAFFING POLLING STATION (BH SENIOR CENTER) ON ELECTION DAY, INCLUDING:

SETTING UP POLLING STATION;

CHECKING IN VOTERS AND VERIFYING REGISTRATION;
ASSISTING VOTERS AS NEEDED, COUNTING BALLOTS, CERTIFYING ELECTION RESULTS, AND ADVISING ON ELECTION MATTERS AS NEEDED.
